

# Speakers

#### James Wurst

Author



James Wurst is well-known among UN journalists as an analyst specializing in international security issues. Based at the UN since 1987, James has been a reporter for the National Journal Group, Inter Press Service, The InterDependent, and LGMA.TV, and an editor for Disarmament Times (New York) and Disarmament Campaigns (The Hague). His work has been published in

anthologies, and he has held numerous positions in the United Nations Correspondents' Association (UNCA), including President (2005).

Dulcie Leimbach is the founder of PassBlue, a digital publication reporting on the United Nations that is a project of the Ralph Bunche Institute of International Studies at the City University of New York. For PassBlue and other publications, she has reported from New York and overseas in West Africa (Burkina Faso, Mali and Senegal) as well as from Europe (Scotland, Vienna and Budapest)

Previously, she was the publications director of UNA-USA, and before that an editor at the New York Times for more than 20 years.

A. Edward Elmendorf initiated this project and is directing it. Ed was volunteer President of the United Nations Association of the National Capital Area (UNA-NCA) from 2005 to 2009. He returned to full-time employment as President and Chief Executive Officer of UNA-USA in 2010, with a mandate to negotiate an alliance between UNA-USA and the UN Foundation. His work in international organizations spans over 50 years.

## About the Book

The book documents 70 years of dedicated and independent action and advocacy for the United Nations and sound US policies in support of the UN, by civic leaders, policy experts, diplomats, and UNA-USA leaders and members across the country. The work of UNA-USA luminaries, such as Clark Eichelberger, Eleanor Roosevelt, Elliot Richardson, Ed Luck, Toby Gati, John Whitehead, and Bill Luers is discussed at length, using original archive material and interviews. Extensive information is featured on the actions of UNA members and chapters. UNA-USA policy studies, human rights programs, and education activities are covered, making the book the first full documentation of the organization from its start. The book concludes with the alliance between UNA-USA and the UN Foundation.
